Council Meeting June 7, 2022, 6:00 PM

A. Called to Order

Having a quorum, the Regular Council meeting was called to order by Mayor Randy Gawith at 6:00 PM. Council members present were Councilor Raymond Doherty, Councilor Derek Turner, Councilor Vernon Sandy, and Councilor Paula Evoniuk. Councilor Tegan Kaneaster and Councilor Aliina Kirby attended via phone conferencing. Department Heads present were Chief William Caldera, and City Recorder Teri Bacus. No citizens were present.

D. APPEARANCE OF INTERESTED CITIZENS

Councilor Evoniuk requests to add the topic of a spay/neuter programs for feral cats to the agenda. Councilor Sandy made a motion to include the topic and Councilor Turner seconded. Councilor Doherty voted yes, Councilor Kaneaster voted yes, Councilor Evoniuk voted yes, and Councilor Kirby voted yes. Motion carried: 6 Yes – 0 No

F. ACTION ITEMS

F-1 Resolution #687 – Adopting the FY2023 Budget – City Recorder presents resolution #687 to adopt the fiscal year 2022-2023 budget. She explained the purpose of the budget which is to hear citizens' testimony on the approved budget. She provides a summary of each fund including General, Street, Sewer, Water, Economic Development, Community Development Block Grant, Library and the Lagoon Fund. She also describes the uses of Coronavirus State & Local Fiscal Recovery Funds. Umatilla County grant funds are also included in the budget for a new Senior Center and for Birch Creek flood protection and prevention. The Swim Bus Program has shifted to the Pilot Rock School District and if any donations are received by the city for the program, they will be forwarded. Councilor Sandy asks if the budget contains enough funds for a third police officer and City Recorder answers yes. No citizens were present for comment. Councilor Doherty made a motion to adopt the budget as written and Councilor Turner seconded. Councilor Sandy voted yes, Councilor Evoniuk voted yes, Councilor Kaneaster voted yes, and Councilor Kirby voted yes. Motion carried: 6 Yes – 0 No

F-2 Resolution #688 Election to Receive State Funds – City Recorder presents a resolution to declare the city's election to receive state revenues which is required by the state. These are funds that come almost entirely from income taxes and are distributed to cities based on population. **Councilor Sandy made a motion to accept**

resolution #688 as written and Councilor Evoniuk seconded. Councilor Kaneaster voted yes, Councilor Kirby voted yes, Councilor Doherty voted yes, and Councilor Turner voted yes.

Motion carried: 6 Yes – 0 No

F-3 Reader Board - City Recorder presents a request for purchase of a reader board. The reader board would be placed near the Pilot Rock Fire District building for access to electricity. She provides an estimate of a lightly used reader board from Sign Men received from Mayor Gawith in the amount of \$18,160.00. The board has a graphic area of three feet by seven feet and the estimate includes installation. Mayor Gawith explains that the board was barely used from the old PGG building in Pendleton. He states that the board is in great condition and the estimate includes our logo and the Fire District logo. He states that this is a good deal. He further explains that the city would only need to use the backhoe and dig a trench for the electrical wiring. The board would also be used by the Fire District for their events. Councilor Doherty asks how it would be controlled and Mayor Gawith explains that the computer must be within 250 feet for use. Councilor Sandy asks about a warranty and Mayor Gawith is working with them now for a maintenance agreement but there will no warranty. Councilor Doherty asks about how the reader board functions and how it is operated. There was discussion on the functioning of reader boards. Availability of parts was also discussed due to the age of the reader board and the usual life span of a reader board is 8-10 years. Power consumption was discussed, and Mayor Gawith stated that the Fire District has agreed to pay for the power usage. Councilor Evoniuk asks if we could set funds aside for maintenance and City Recorder stated that \$5,000 was allotted in the budget for a reader board. Councilor Sandy states that it's a great idea and a heck of a buy. Estimates of new reader boards was discussed and Councilor Sandy states that he has investigated the cost for a business, and they are \$70,000. Councilor Doherty is concerned with the longevity of the reader since it is already a couple years old. There was further discussion on how long it would last, the current condition and if parts are available. City Recorder provided options on where to allocate the funds from. Councilor Sandy made a motion to accept as written and leave \$5,000 that was allocated is in the budget for a reader board to be used for maintenance and the total cost would be paid by Coronavirus Relief Grant Funds. Councilor Doherty seconded the motion. There was discussion on the material that would be on the reader board and the city having access to the reader board. Councilor Turner says that we could advertise for local businesses for a small fee, and everyone agreed that it was a good idea. It would help with any maintenance costs. Councilor Turner voted yes, Councilor Kirby voted yes, Councilor Kaneaster voted yes, and Councilor Evoniuk voted yes. Motion carried: 6 Yes - 0 No

F-4 InterMountain Education Service District (IMESD) Agreement – City Recorder presents an interagency service agreement. The agreement is for continued enterprise level information technology department services. The services are for the architecture, hardware, software, and networking of computers, and to provide support to technology end users. The annual fee is \$5970. Chief Caldera explains that the Police Department is very restrictive on who can service their equipment. They have very sensitive material, and it is considered criminal justice information and they are required to be very protective of the records. The personnel that work on their technology are required to be certified by the state. IMESD also assisted in the technology in the patrol vehicles. Councilor Turner made a motion to approve the agreement and Councilor Sandy seconded. Councilor Doherty voted yes, Councilor Kaneaster voted yes, Councilor Evoniuk voted yes, and Councilor Kirby voted yes. Motion carried: 6 Yes - 0 No

F-5 Resolution #689 Sewer Rate Increase - City Recorder presents resolution #689 which increases the sewer rate by 4%. The residential rate increases \$1.73, and the sewer utility reserve fee increase is .24¢. The total increase for residents is \$1.97. The sewer department operating costs continue to increase. The last sewer increase was in August 2019 in the amount of 3%. Current inflation is over 8% mainly due to fuel price increases. Councilor Turner made a motion to approve resolution #689 and Councilor Sandy seconded. Councilor Kaneaster voted yes, Councilor Doherty voted yes, Councilor Evoniuk voted yes and Councilor Kirby voted yes. Motion carried: 6 Yes – 0 No

F-6 Spay/Neuter Program for feral cats – Councilor Evoniuk would like to use \$3,900 SLFRF grant funds for a spay/neuter program. It would be for 30 cats to assist in reducing the feral cat population in city limits. She has coordinated with the mobile Veterinary Services, Hansen's to provide the service. The vet can provide the service for 10 cats each trip to the city. The service includes the exam and ear clipping. She is proposing for citizens who would like to use the service to sign up at City Hall and pay a fee of \$20 or \$30. If there is enough interest, we could decide to extend the program or cancel. The program would be for Pilot Rock citizens only and City Hall would issue a "ticket" to present to the vet for the service. Chief asked how many traps are we talking about and she replies that she has 4 and she believes there are a couple of people with traps. She also suggested that we could advertise the program to see if there is any interest. The legality of trapping inside city limits was discussed and Pilot Rock Municipal code does allow trapping as part of a spay/neuter program. Councilor Doherty asks about funding and believes that the program does not fit into the allowed use of the grant funds. **Councilor Doherty made a motion to table the program until there is more information and Councilor Turner seconded. Councilor Kaneaster voted yes, Councilor Sandy voted yes, Councilor Kirby voted yes and Councilor Evoniuk voted yes. Motion carried: 6 Yes – 0 No**

G-1 Department Head Report – Chief Caldera provided an update on the police officer position. Only one application has been received. To schedule the physical, a minimum of 5 applicants are required. He also informed council that the shortage of police officers is statewide. This was the fifth cycle held within the past two years.

City Recorder states that the warranty final walk through has been scheduled for June 17, 2022, with Pilot Rock Public Works Director, Engineers Anderson Perry, Department of Environmental Quality, United States Department of Agriculture and the contractor.

City Recorder provides update on the Public Works Director who is dealing with a family illness and must take time off. Councilor Turner made a motion approving time off for his family and Councilor Sandy seconded. Councilor Doherty voted yes, Councilor Kaneaster voted yes, Councilor Evoniuk voted yes, and Councilor Kirby voted yes. Motion carried: 6 Yes - 0 No
